DECLARATION

WHEREAS, it was Notified by Government in the Revenue Department vide Notification **NO. F. 09 (01)-REV/ACQ/VI/17** dated **08-08-2017**, that the land/ lands described in the schedule hereto (hereafter referred to as the said land / lands) was / were needed or likely to be needed for the public purpose, namely for the purpose of **construction of Agartala-Akhaura New Railway Line Project** under **Sadar** Sub-Division in **West Tripura** District;

AND WHEREAS, the Government of Tripura is satisfied, on the basis of the observation made by Administrator of the concerned District that the Rehabilitation and Resettlement Scheme shall not apply, because no displacement of family / families will occur due to proposed acquisition process;

AND WHEREAS, the Requiring Body has deposited the cost of land to be acquired with the Collector;

NOW, THEREFORE, it is hereby Declared under the Provision of **Section 19¹** of the Land Acquisition & Rehabilitation Act that the said land / lands is / are required for the public purpose, namely for the purpose of **construction of Agartala-Akhaura New Railway Line Project** under **Sadar** Sub-Division in **West Tripura** District.

The Government is also pleased to direct the Collector, **West Tripura** District under **Section 20** of the said Act to proceed with the works.
