WHEREAS, acquisition of land area measuring 5.39 acres in R. S. Plot No/Nos. as specified at "Annexure-A", Class as specified at "Annexure-A", in Khatian No/Nos. as specified at "Annexure-A", under Charipara Sheet No. 2/P Mouja of Badharghat Tehsil under Sadar Sub-Division for the purpose of construction of Agartala- Akhaura New Railway line project to be constructed/developed by the North East Frontier Railway, (Construction Organization) is/are proposed.

No. II, Agartala, West Tripura -Member (x) Dr. Mihir Kr. Das, Scientist of Tripura State Pollution Board -Member (xi) CDPO, Dukli under Sadar Sub-Division -Member (xii) Sri Santosh Kumar, Asstt. Engineer/Con.-I, N.F. Railway, Agartala -Member (xiii) Sri Debananda Debbarma, Surveyor DM's Office, West-Member as/have been formed to consult, to survey and to take public hearing after publication of this Notification.

WHEREAS, the aforesaid team will conduct hearing on 09-03-2017 at 11.00 A. M. at Badharghat TK Office on which all concerned are requested to remain present with their claims/objections/suggestions, if any.

WHEREAS, the land is within the jurisdiction of Gram Panchayet/Village Committee/Nagar Panchayet/Municipality/Municipal Corporation, the members of Gram Sabha/Village Committee/Nagar Panchayet/Municipality/Municipal Corporation may give consent/approval to the proposed project.

THE concerned land owner as specified at "Annexure-A" himself/herself or his/her representative may remain present for hearing for consent/approval for the project.

THE process must be completed and SIA report must be submitted along with the plan (SIMP) within the time specified in the Rule 3.

ANY attempt at coercion or threat against the process during the specified period will render the exercise null & void.
