WHEREAS, acquisition of land area measuring 2.409 acres in R. S. WHEREAS, the land is within the jurisdiction of Gram Panchayet/Village Committee/Nagar Panchayet/Municipality/Municipal Corporation, the members of Gram Sabha/Village Committee/Nagar Panchayet/Municipality/Municipal Corporation may give consent/approval to the proposed project.

THE process must be completed and SIA report must be submitted along with the pian (SIMP) within the time specified in the Rule 3.
